

Field corn 'events' in the US

Up-to-date March 2025

All Bt trait stacks in the Handy Bt Trait Table are combinations of a limited number of plant transformations, or 'events'. Inbred lines with these events are crossed to produce hybrid seed corn for commercial sale. The reference table below lists the events in Bt hybrids sold in the U.S. in alphabetical order with their trade names.

** Every event has a registrant (a company which developed it) and an EPA registration number. Companies may have merged or changed, but the registration numbers remain the same. Registration numbers are useful for searching government databases.

** Bt proteins in plants may be similar to endotoxins from nature or modified in the lab. Proteins vary in activity, controlling different pest species as noted in the caterpillar and rootworm columns. Pest acronyms: ECB European corn borer, TAW true armyworm, WBC western bean cutworm, WCR/NCR/MCR western/northern/Mexican corn rootworm.

** Many Bt events also express proteins which allow plants to tolerate one or more herbicides, as noted in the Weeds column.
